TERMS & CONDITIONS

1. Above prices are basic landed cash prices.

2. An Early payment Incentive (EPI) of Rs.75/MT/Day will be applicable for credit customers if full payment is received before the IFC period in single transfer.

3. Prices of non-prime grades shall be lower by Rs. 800/MT than the respective prime grade.

4. GST will be charged extra @18%.

5. Unloading at customer's end will be arranged by the customer.

6. For the material procured against Cash terms, its payment will be due on the 3rdday from the date of invoice (eg. Invoice Date 1st:: Due Date 3rd).

7. Quantity discount is applicable on prime & Non prime grades on monthly basis except utility, sweeping, waste grades and powder.

8. PP, HDPE & LLDPE grades would not be allowed to be combined for the purpose of QD computation.

9. QD to be settled by credit note after completion of lifting on post sales basis in the following month.

10. QD is not applicable for deemed export and deemed export quantity not be clubbed with domestic sales quantity for computation of eligibility of QD.

11. QD to be settled by credit note after completion of lifting on Post Sales basis in the following month.

12. If payment is not received as per the payment terms, interest will be charged @ 36% per annum for the delayed period from the Date of Invoice.
